## **OICA, CMI4K and Sunbeam Family Services Receive Grant from The Oklahoma Group**

**OKLAHOMA CITY** – Count Me in 4 Kids (CMI4K), a collaboration between Sunbeam Family Services and the Oklahoma Institute for Child Advocacy (OICA) and other child advocacy groups that bring awareness to the needs of Oklahoma’s children, has received a work project grant from The Oklahoma Group (TOG).

TOG is a student-led consulting organization from the University of Oklahoma that provides pro bono services to nonprofits in central Oklahoma.

The framework for TOG’s project comes from research done by Sunbeam that identified trends in some of the most impoverished zip codes in Oklahoma County relating to the well-being of the state’s children under age 5. The trends show that children in these zip codes, six of which are in Oklahoma County, have the lowest wellness scores: Forty percent come from families with incomes below the federal poverty level. Also present are the highest numbers of child abuse and neglect referrals in the state, the highest levels of teen births and highest levels of uneducated mothers.

TOG’s project will focus on services that help to build family stability and economic well-being, which is essential to improving the quality of life for children and families within these zip codes. The research will identify the unmet needs of impoverished children, pinpoint gaps and duplication in services and develop a strategy to address those needs.

“This comprehensive survey of available resources for vulnerable children will provide insight into how the nonprofit community can collaboratively meet the needs of children more effectively and efficiently,” said Sunbeam Family Services CEO Jim Priest.
