WE STRIVE TO SERVE THE CHILDREN OF GREATEST DISADVANTAGE (THOSE THAT ARE STATISTICALLY THE LEAST LIKELY TO SUCCEED IN SCHOOL WITHOUT EARLY INTERVENTION). GRANDPARENTS WERE ALSO ABLE TO INCREASE ACCESS TO COMMUNITY SERVICES, SUPPORT THROUGH RESPITE CARE, AND ITEMS SUCH AS SCHOOL SUPPLIES, WHICH ASSISTS WITH FINANCIAL STABILITY. COUNSELING SERVICES: THE SUNBEAM COUNSELING PROGRAM TOUCHED THE OKLAHOMA CITY COMMUNITY IN MANY VARIED WAYS DURING FY17, BY PROVIDING COUNSELING AND MENTAL HEALTH SERVICES, SUPPORT, TRAINING AND EDUCATION, AND SUPERVISION FOR FUTURE COUNSELORS. THE COUNSELING PROGRAM PROVIDED 6,422 UNITS OF SERVICE AND SERVED 1,458 CLIENTS DURING FY17. THE MAJORITY OF THOSE SERVICES WERE INDIVIDUAL, FAMILY, AND MARITAL THERAPY FOR CLIENTS. THROUGH CLIENT SURVEYS AND OTHER QUALITATIVE MEASURES, THE OVERALL IMPROVEMENT IN FUNCTIONING AND QUALITY OF LIFE OF PEOPLE HAS BEEN IMPROVED THROUGH SUNBEAM'S COUNSELING PROGRAM.
